



# Dr. Phillips Pop Warner Little Scholars, Inc.

## PARENT CONTRACT

The Dr. Phillips Pop Warner Football and Cheer Association wants to ensure that we provide a safe and productive environment for all participants, parents, visitors, coaches and board members. Below is an outline of some of the rules and requirements for each participant/parent as we move in to the 2017 season. Please read and initial next to each item.

\_\_\_\_\_ 1) I understand that by initialing this line I agree to the Parent Code of Conduct outlined on the back of the Pop Warner Consent form I have completed for my child. This includes, but is not limited to avoiding vulgar language and gestures directed at children, volunteers and game officials. It also includes avoiding disruptive behavior at all Pop Warner events, this include verbal attacks on coaches and board members.

\_\_\_\_\_ 2) I understand that alcohol and tobacco products are not permitted at Pop Warner events.

\_\_\_\_\_ 3) I understand that DP Pop Warner is strictly a volunteer based program, therefore, I agree to work **one concession shift for each child** I have in the program during the season. (If two children are on the same team, you must work two shifts for that team. If you have children on different teams, you must work one shift per team)

\_\_\_\_\_ 4) I understand that there is a \$250 registration fee per child, due before July 17, 2016. If this fee is not paid in full on or before that date, equipment will be withheld until payment is received. I also understand that \$25 of this fee is a non-refundable admin fee. The rest of this payment may be refunded until August th. There will be **no more refunds issued after August 6, 2017.**

\_\_\_\_\_ 5) I understand that it is my responsibility to have my child at games and practices on time, or their playing time may be affected. Arrival times for games and practices will be set by coaches, and will be strictly enforced. DP rules state that a participant must attend no less than two practices per week to play/cheer in the game on Saturday (weather permitting).

\_\_\_\_\_ 6) I understand that DP Pop Warner is not a child care option. I agree to be present to supervise my child. If I cannot be present I will make arrangements with another adult to supervise my child. DP Pop Warner cannot be responsible for children dropped off without adult supervision. If you must leave the field during practice or a game, please notify your coach. At this time, you must be within 10 minutes of the field in case of emergency or severe weather changes.

\_\_\_\_\_ 7) I will not disrupt practices or games to address any issues. All issues will be dealt with in a private manner, and must follow the proper chain of command. (Please start with civilized conversation with your child's head coach). Two warnings will lead to dismissal from the team.

**Failure to abide by these rules will render a written warning. Two written warnings will lead to removal from the organization. All Board decisions on these issues are final.**
